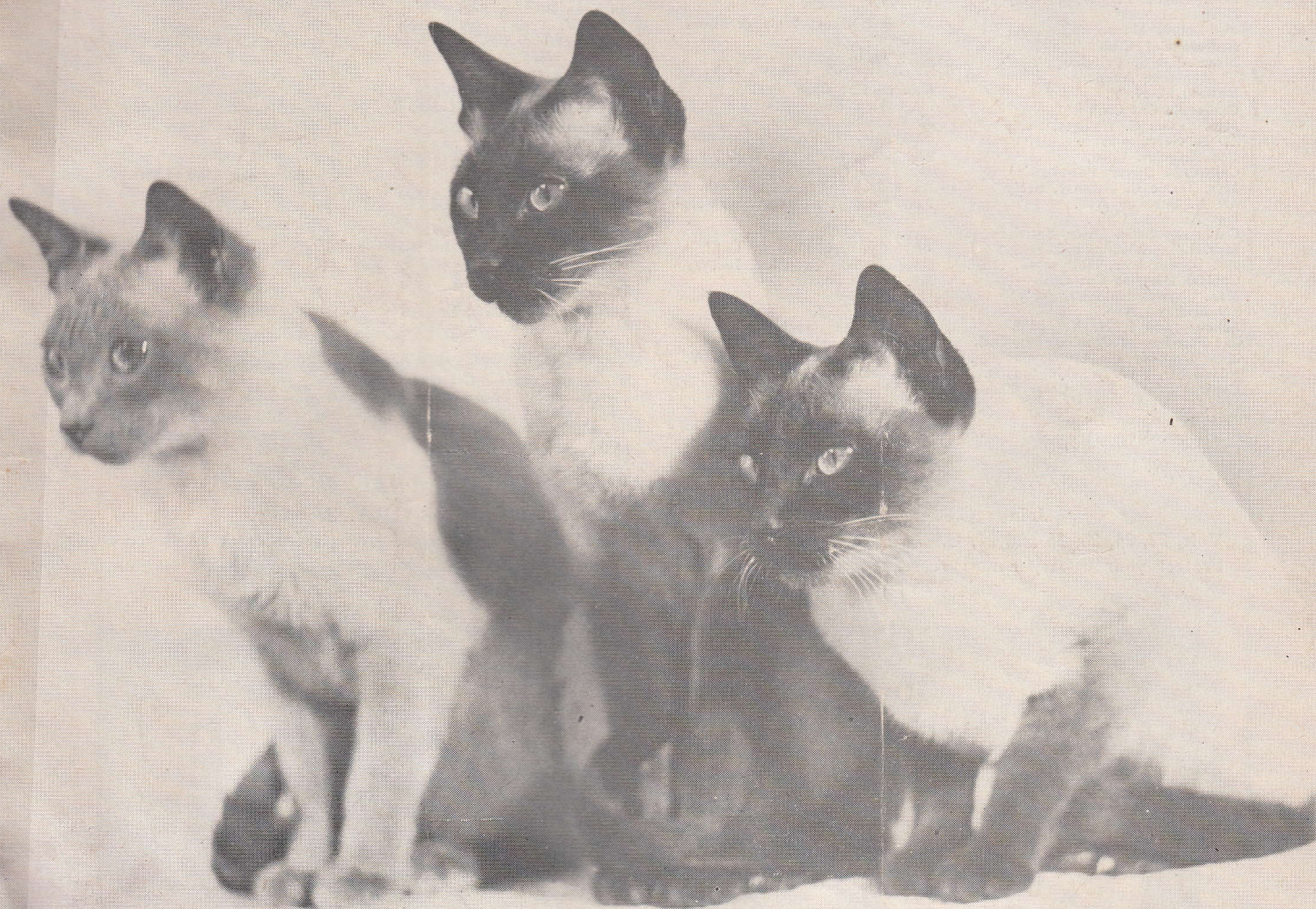

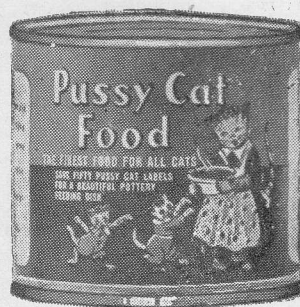

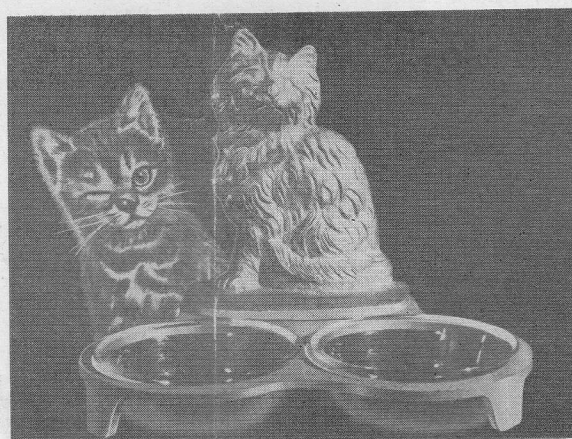

## Help for the Congo

But here is my problem: A great percentage of our cats die while they are still kittens. They have a watery substance running out of their mouth, and occasionally from the rectum as well. They become very weak, especially in the hind quarters. Usually they seem to be in pain. They finally die at the end of a choking spell. We think perhaps it is worms, as everything and everybody has worms out here (Middle of the Congo). But maybe it is something else. At any rate, we would like to know if there is something we could do for them. If you could offer any suggestions we would appreciate it. Perhaps you could send us some medicine. I am sending this letter by airmail. I do hope CATS can help me before I lose my current cat of whom I am very fond. He is not sick—yet!

This may be an old story, but in case it is not, I will pass it on. Our cats and rabbits had a nasty itch all over their bodies. We cured it by applications of lard (1 cup) mixed with kerosene (2 table-spoons).

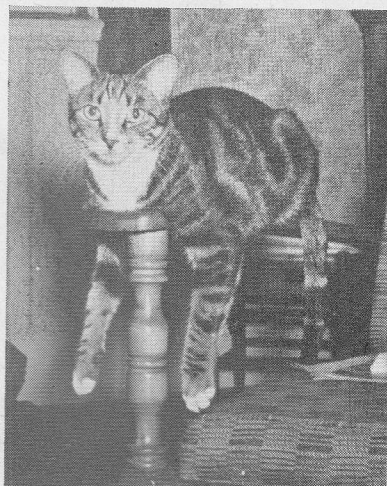

## On Teaching Cats

I note with great interest the article in the March issue by D. Reinke on teaching a cat. I claim they will respond quicker and better to praise and petting than to a tempting morsel of food.

I adopted Sue at about eight weeks of age and soon afterward started training her by lifting her right paw and shaking it very frequently when I found her in a sitting or standing position. At the same time I would say, "Shake!" over and over. Also at times I would say, "Miaow—speak" several times in succession. Very soon I noticed that Sue would slightly lift her right paw on some occasions when I would approach her. So I tried her out



by sitting her on a chair before me and I commanded "Shake!" and up came her paw for a shake. I then commanded, "Speak!" and she opened her mouth and let out a loud "miaow." I always pet her and say "Smart Cat!" and she bristles all over and struts around in proud fashion. She is now over five years old and still does her stunts and all I have to do is say "Smart Cat!" a few times and she will jump up on a chair and sit in readiness to shake and speak. I have never given her any food in recompense for her tricks; only petting and praise.

She has other tricks like retrieving a ball and sitting astride the arm of a chair (see cut). She seems to enjoy being photographed.

You may want to tell your readers about making with scissors a ball about one inch diameter out of fine sponge rubber. Obtain sponge intended for bath use. It proves best for retrieving. Put it away after the cat has retrieved it a few times and becomes tired. Do not leave it around for a regular plaything as the cat will then play with it and forget about retrieving.

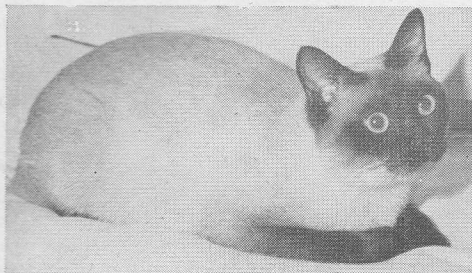

# RABIES IS NO RARITY WITH CATS, RECORDS REVEAL

Lack of knowledge can prove a dangerous weapon, especially when such lack is manifested in a communication designed for reader consumption and influence, and which uses for ammunition not facts, but skepticism directed at a so-called non-existent cat disease. Just as abdominal surgery was the target of scornful attacks at its inception, and psychoanalysis an object of ridicule before it was accepted by the public, so today medical science is again confronted with an attack on one of its discoveries, the protective inoculation against one of the lesser known cat diseases, *hydrophobia*.

Since facts are so easily accessible on both preventative and prevalence, it is doubly amazing that such an attack, obviously based on a wealth of misinformation, has been brought forth with such uncompromising conviction.

In the February issue of CATS, Mr. Truman Pierson, writing on rabies, challenged me to bring on my proofs that this disease exists in cats. This I propose to do, but first I should like to express my complete bewilderment that such a condemnation should spring from an article no more designed to scare than any other article presenting "new" material. Because rabies is not as common as enteritis or distemper, does that mean it must be spoken about in whispers? Because vaccine is the only known preventative, should the subject be taboo? Because, when an epidemic strikes, it is only the free-running alley cat that is exposed, should the matter be shrugged aside as of comparative unimportance?

According to the charts of the U. S. Bureau of Animal Industry, forwarded to me by L. T. Giltner, Acting in Charge, Pathological Division, there were 207 positive cases of rabies in cats in the U. S. in 1938. In 1939, there were 268 cases, in 1940, 260; in 1941, 294; in 1942, 250; in 1943, 316; in 1944, 419; in 1945, 466, and in 1946, 455 cases. States suffering the heaviest 1946 outbreaks (cats) were: Georgia, 76 cases; Texas, 64; Alabama, 36, and California, 30.

It is noteworthy that the northwestern part of the U. S. is virtually free of rabies in ANY animal, while the southern and mid-western states continue to report outbreaks. Incidence of rabies in cats naturally cannot compare with rabies in dogs, but it is significant that since 1938 the number of positive cases has more than doubled, while that in dogs, though fluctuating, has remained about the same. 1947 figures are not available at this time, but are being compiled by the Bureau of Animal Industry from reports of the livestock sanitary official and health officer in each state.

Rabies cases in this country are definite-

ly increasing. In an effort to participate in a control program on a national scale, Bill HR 3289 was introduced in the House of Representatives, amending certain Acts under which the Bureau operates, to include within their provisions, dogs and OTHER DOMESTIC CARNIVORA. The committee on rabies wholeheartedly endorsed the report of the special committee of the A.V.M.A., referring particularly to a meeting of special representatives to draw up definite plans.

Without the kind cooperation of the eminent Dr. Morris Fishbein, Editor, Journal of the American Medical Ass'n., it would be impossible to bring you the results of this meeting. As it is, I have in my possession that part of the Nov. 22, 1947 Journal devoted to this subject. Since the report is too lengthy to reprint here, only such portions that should prove interesting to the Cat Fancy will be touched upon.

The Conference unanimously agreed that in a rabies control program it is desirable for the federal government to participate, co-operating with the several states by contributing funds and personnel. Further, such program shall include "adequate diagnostic facilities," "control of animals (dogs, cats, and wild life) capable of transmitting the disease," and "mass immunization of susceptible animals, especially dogs." The Conference agreed also that, "an educational program should be launched by appropriate authorization, representing federal, state and local agencies, to explain the necessity of control measures, including the efficacy of the rabies vaccines now approved by the U. S. Bureau of Animal Industry and the National Institute of Health."

Those taking part in the Conference, held at the University of Pennsylvania, April 9, 1947 were representatives of the following, headed by Dr. R. A. Kelsor: American Public Health Ass'n., American Medical Ass'n., U. S. Public Health Service, Bureau of Animal Industry, U. S. Livestock Sanitary Ass'n., American Animal Hospital Ass'n., and American Veterinary Medical Ass'n.

A name familiar to all in the East, and possibly to those living in other sections of the country as well, is Irwin Schroeder, D.V.M., Chief of Staff, Angell Memorial Animal Hospital, Boston, Mass. Dr. Schroeder recently answered a few questions based on his years of medical experience. Here they are:

Q. Are cats subject to rabies?

A. Yes, cats are susceptible to rabies as are all warm blooded animals.

Q. Have you ever treated a case of rabies in dogs? Cats?

A. The answer would, of course, be no. Once an animal shows symptoms of rabies, there is no known treatment of any value. Once a case is recognized as rabies, the animal invariably succumbs to the disease within a period of seven to fourteen days. (this proves that there is no "serum shooting" in connection with rabies. R.S.)

Q. Do you consider prophylactic inoculation an effective means of protecting animals in infected areas?

A. Yes, this is one of the recognized preventative measures taken in areas where there is an outbreak of rabies. All recognized Boards of Health throughout the U. S. and Canada include inoculation, with other measures of prevention when there is an outbreak.

Another progressive veterinarian, Dr. H. F. McDonald of Utica, N. Y., addressing the Mohawk Cat Club (April 1947) on cat diseases, briefly outlined each disease a cat is subject to. His list included—rabies!

It was my intention to include with this material excerpts of letters received from various individuals. However, I think the above is sufficient proof for even the most skeptical that rabies IS a cat's disease and that vaccine IS the only known preventative in an infected area (aside from keeping the animal under lock and key).

I cannot pretend to understand why Mr. Pierson is so strongly against serums since he did not clarify his remarks. Consequently they have to be accepted at face value. But classing the medical profession as "serum shooters," is ridiculous. Many of our foremost breeders do their own "serum shooting," and to condemn one group is to condemn the other.

In closing, I wish to go on record as approving wholeheartedly not only of serums, but of the men who shoot them. High walls may keep out rabies, but no wall is high enough to keep enteritis out. And what is the answer when enteritis strikes? SERUM.

# CLAIRE WALLACE, CANADA'S ACE RADIO COMMENTATOR HAD A PERSIAN THAT BECAME DARLING OF THE DOMINION

Almost any time Canadian radio listeners tune their dials to Toronto's Claire Wallace and her "They Tell Me" program, they are likely to hear a cat. Or a horse or deer, an eagle or some other animal, bird or reptile—but more probably a cat.

One of Canada's top-ranking radio commentators, with her own nationally broadcast program, Miss Wallace is a lover of cats. Her Toronto home is never without one or more, usually Persians, and in her more than ten years of broadcasting she has often introduced the pets to her millions of listeners. Furthermore they like it, as evidenced by the flood of mail which descends on the "They Tell Me" office staff whenever a new cat story "breaks." In January, the Story of CATS MAGAZINE was the subject of a broadcast.

At present two six-month-old brothers, George and Sam, dominate the Wallace household. George is blue, lively, intensely curious and highly intelligent; brother Sam is the quiet type, content to display his black beauty as a foil for George's lively caperings. The pair were given to Miss Wallace by Margot Wilson, noted Canadian animal artist, who describes them as "practically" Persian. Apparently some slight tinge of doubt about their ancestry requires the qualification.

George and Sam are successors in Claire's affections to Pussy Willow, a silver-blue Persian which became overnight a radio personality almost overshadowing its owner. When Miss Wallace travels her welcomers sometimes still ask first for Pussy Willow. It happened like this.

A former newspaperwoman in Canada and England, Claire Wallace applies her news training to radio work, specializing in the "story behind the story," written and told in a breezy, heart-warming style which she has made famous.

A couple of years ago Claire broke her knee-cap and was confined to her home while the injury mended. Her room was wired so that broadcasts could go on uninterrupted, and one day she chose to let her kitten sign-off for her. The kitten failed to cooperate; no kittenish meow would he give, and Claire had to apologize to her listening audience. She overcame the difficulty next day by dangling a piece of liver near its nose but in the meantime hundreds of letters poured in giving advice as to how to make the kitten talk.

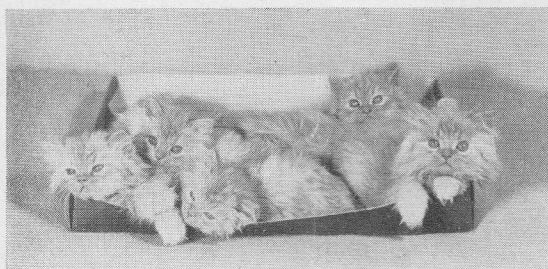
So great was the interest and so many people enquired for the cat's name that a contest was staged to choose a name. Pussy Willow was christened by popular vote. Within succeeding weeks he easily became Canada's most famous cat. He

was on the air for three weeks, replies to his heavy fan-mail with a photographic portrait autographed with a paw print.

Miss Wallace receives hundreds of invitations each year for personal appearances as guest of honor or guest speaker at functions ranging from club luncheons to fall fairs. Pussy Willow was soon sharing her invitations. Bradford, Ont., invited Claire and kitten to its annual ice carnival—one of several similar invitations—and sent a set of four hand-

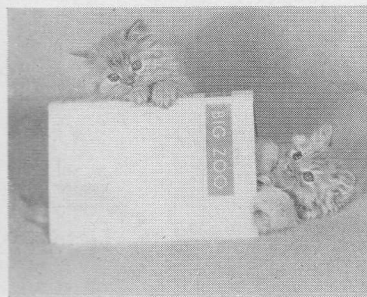
made ice skates, miniature skis and ski poles, and a hand-knit sweater so that Pussy Willow would feel at home among the snow beauties. A brass band and a chauffeur-driven automobile were ready to greet the kitten on arrival. Huntsville, Ont., exchanged correspondence via the town mayor speaking on behalf of Huntsville's cat population in pressing its invitation.

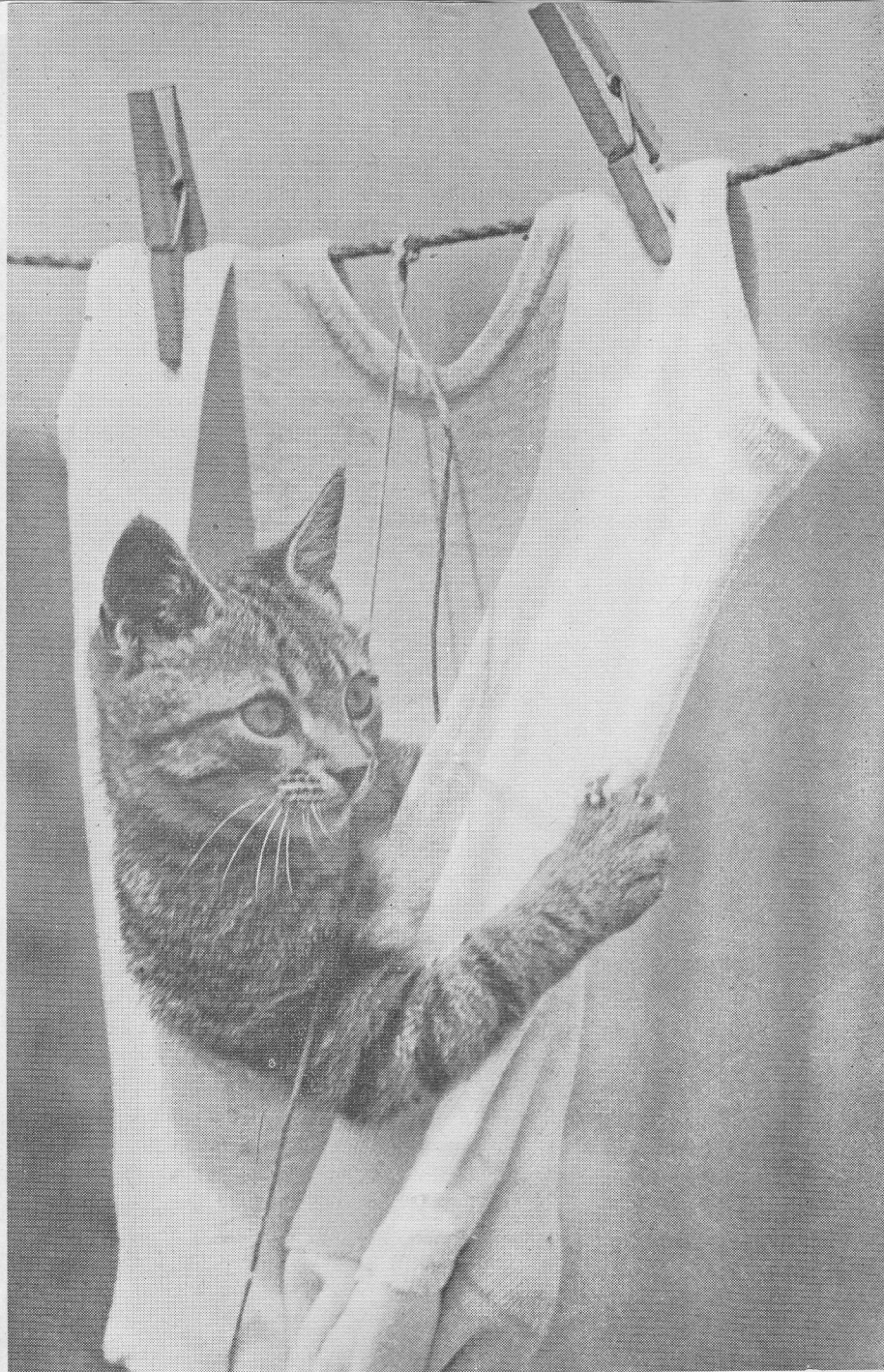

Forty-one show cats have won the title of 1948 All-Eastern in their respective classifications, with the long hair aristocrats, of course, carrying off the most honors. Six states are represented with New York leading the way with 15, followed by Massachusetts with 10; Connecticut with 7; New Jersey with 6; Pennsylvania with 2 and New Hampshire, scoring for the first time with 1.

The selections are made on the basis of performance in exhibitions during 1947-48,

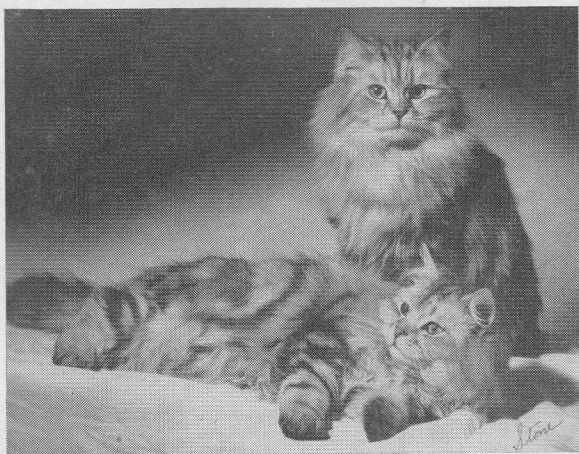
by a mathematical system applied to the results. The winning cats therefore, are neither the personal choices of CATS nor the opinions of any one person or group. The listing does not include the results of the Long Island Breeders (CFF), but it is doubtful changes would be necessary.

There are six less cats listed than last season, one factor being that Canadian-owned felines are not included in these rankings. Eleven of the aristocrats repeated their wins of 1947, of which four

were 1947 All-American choices.

The Domestic Short Hair, Ch. Aztec's Belinda (AA-47), silver tabby female, owned by Mrs. F. W. Freudenthal of Darien, Conn., is the top-scoring representative in the rankings. This is an unusual surprise. Top ranking male is the cream, Dbl. Ch. Rosegate's Sun Ray, owned by Mrs. Elsie M. Collins of New York, N. Y. These two performers represent the East for the grand title of All-American Cat of the Year.

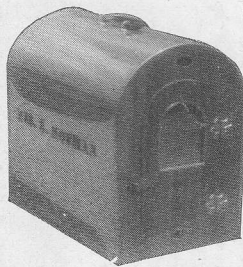

Toronto's dressmakers offered a white tulle dance frock, with cerise sash in asking Pussy Willow to be honored guest at the annual trade ball. Finally Pussy Willow's admirers became so numerous that an entire radio program was given over to the silver-blue pet.

Pussy Willow is now retired. Placed in a country home while Claire was travelling one summer, he developed such a love for country life that he showed little interest in a return to the city. Miss Wallace returned him to his farm home.

A radio veteran now, Claire is still first and foremost a crack news reporter. When she is on the trail of a story no effort is too great to get the facts. She has travelled widely, all over Canada and the United States, to Mexico, the Caribbean

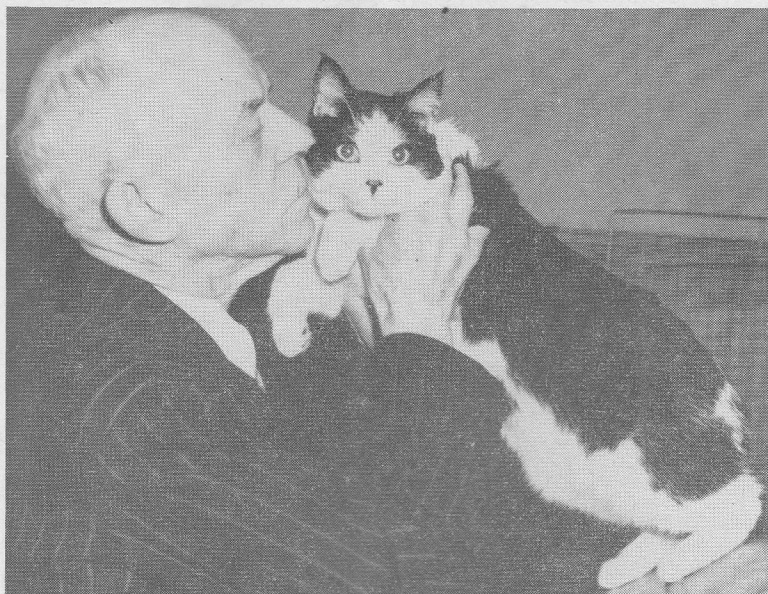
and other countries, and flew the Atlantic last November to attend the Royal wedding of Princess Elizabeth and the Duke of Edinburgh. From London, England she broadcast her stories direct to Canada.

To get factual material she has explored a gold mine 3,000 feet below the ground, has walked the ocean floor in a diving suit, has climbed Rocky Mountain peaks, and learned to fly her own plane. Last fall the Six Nations Indians, largest group of Indians remaining in Canada, made her an honorary princess, an honor given only to leading personalities and rarely accorded a woman. # MY CAT SAVED MY LIFE!

Yes, my cat, Dee-Dee saved my life!

He's just a plain cat, but I hope by writing this, it will remind people to be good to their pets. You never know when your pets may be good to you.

The night Dee-Dee saved my life was April 20, 1947. I was at my West Dunkeld Place home here in Denver. After a busy day and feeling quite tired I went to bed. Gertrude, my wife, was visiting friends in California.

Soon I was fast asleep.

Suddenly, I was awakened by Dee-Dee who was pawing at my face. Sometimes he gets too chummy and playful, and I thought this was one of those times. He missed my wife I know, during her stay on the west coast. So I simply pushed Dee-Dee away—I was only half awake.

But Dee-Dee continued to torment me, now pawing and clawing at me in earnest, until I was wide awake. "Go on to bed Dee-Dee. Let me sleep," I said. But the persistent clawing continued. Dee-Dee never acted like this before. So I turned on the bed lamp. The clock showed it was two o'clock.

Then suddenly I was gripped with fear,

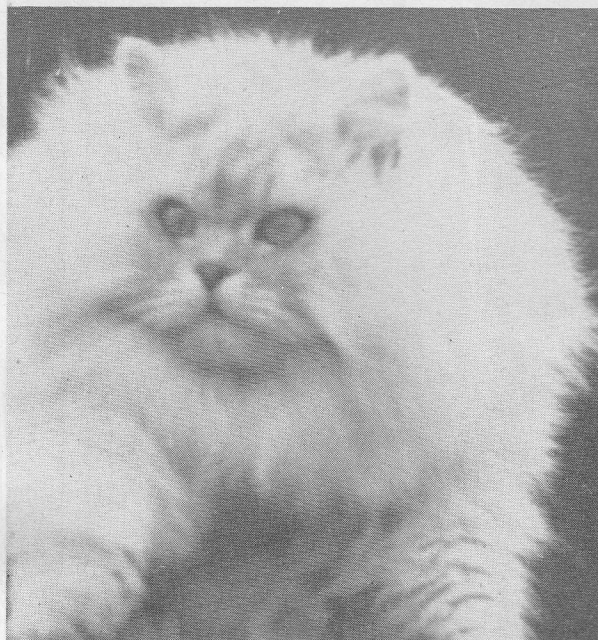
